You have the right to access your personal information held by Charles Monat, and to ask Charles Monat to correct or delete your personal information where it is inaccurate or out-of-date. Furthermore, you are entitled to request for portability of your data and to restrict further processing of data, to withdraw your consent or to object against the processing. This all within the limits of the applicable laws. If you wish to exercise a right, or if you have any question or concern regarding the way in which your personal

The withdrawal of consent shall not affect the lawfulness of processing based on consent before its withdrawal. You always have the right to lodge a complaint with the relevant supervisory authority. Please be aware that exercising some of these rights may mean that Charles Monat will be unable to provide its services to you because it concerns information that is essential to Charles Monat being able to do so.

7. WHETHER THE PROVISION OF PERSONAL INFORMATION IS MANDATORY AND THE CONSEQUENCES OF REFUSAL TO PROVIDE

It is not mandatory for you to provide all of the personal information Charles Monat asks you to provide, but if you refuse to provide your personal information, your refusal may restrict the availability of insurance that can be placed through the services provided by Charles Monat, or otherwise adversely affect the ability of Charles Monat to provide its services in a timely and satisfactory manner.
